*The Spot/Extended Round Fees of Rs. 6000/- will be adjusted in the Seat Acceptance Fees/Part Institutional fees. In case a Candidate is not allotted a seat in the Spot/Extended Round of Counselling, His/her fees of Rs. 6000/- will be refunded after the completion of Admission process.

NOTE:

- ❖ All the candidates who have not confirmed their seat are eligible to participate in Spot/Extended Round of Counselling.
- ❖ All the candidates willing to take part in Spot/Extended Round will have to Submit the part Institutional Fees of Rs. 6000/- in advance.
 - In case of Allotment of Seat in Spot/Extended Round, the deposited fees of Rs. 6000/- will be adjusted against the Institutional fees and the Candidate will be required to Deposit his/her Balance Institutional Fees in the given schedule.
 - In case a Candidate is allotted a Seat and then he/she does not want to continue with this Allotted Seat, the Part Institutional Fees of Rs. 6000/- will be Forfeited and WILL NOT BE REFUNDED.
 - In case a Candidate is not allotted a seat in the Spot/Extended Round of Counselling, His/her fees of Rs. 6000/- will be refunded after the completion of Admission process.
- ❖ Candidates who have withdrawn their seat in previous round of counselling are also eligible for Spot/Extended Round of Counselling but will have to Submit the Part Institutional Fees of Rs. 6000/-, irrespective of fact that he/she had earlier paid the Institutional fees.
